## Being a Molecular Enhancer Practitioner Representative

The Molecular Enhancer is a tool. It does not heal or cure; it helps the body create its own energy through resonance or if you like, molecular vibration.

The Enhancer works because it takes advantage of the principles of molecular resonance. It has been noted that when the body has enough energy to power its own systems, the correct nutritional/chemical support and a positive attitude/spirituality, it has a better chance of correcting itself or as some say, “healing itself.”

The Molecular Enhancer is meant to be a support in the larger picture of health.

Breakdowns in the physical body are increasing at an alarming rate. Mainstream articles have been written about the “failing power plants inside cells (that) give rise to debilitating diseases” (US News and World Report, Nov. 3, 2003: “Energy Crisis”). The Molecular Enhancer could be a part of the solution to this problem.

## Molecular Enhancer Practitioner Representatives - Intent

The Molecular Enhancer is not a profit-centered business. Our focus is to create strong educational materials, keep the cost down for the end-user and stay mindful of those we are assisting and educating.

The Molecular Enhancer has **Practitioner Representatives who get a commission for the time they take sharing/educating others about the Enhancer**. While some might see this as merely semantics, to us it is about intent. It is the attitude with which we do business.

Most of the people interested in the Molecular Enhancer are in a very vulnerable place. Many times they are scared. We are not selling comfort items; we are offering to sell them a device that might help their bodies create enough energy to get beyond the challenging place they are in.

In our experience, people in this place need a lot of kindness and patience, not the pace of a quick sell. We do not view the selling of Enhancers as a huge moneymaker. While it has the potential to bring in some money, our view is that it is a service, a passing on of information with a hands-on approach that can benefit people.

## Commission for time spent

Dan Dial’s Molecular Enhancer™ sells for \$2490 (US & Canada) and \$2680 (international), plus shipping and handling. **The purchase price for each Practitioner Representative's first Enhancer is at the regular price.** For each additional Molecular Enhancer sold thereafter, a Practitioner Representative receives a \$250 commission.

Each Practitioner Representative will have an ID number. Commissions will only be paid when your ID number and full name are provided on the order form. Commissions are distributed on the 1<sup>st</sup> and the 15<sup>th</sup> of each month.

Payments for Molecular Enhancers are made directly to DCD Technologies LLC by credit card (Visa and MasterCard), on our Internet order system or via fax/mail.

Due to security concerns, we do not take credit-card orders via e-mail. Order forms can be downloaded from the Web site under the *Ordering* tab at the top.

Some Practitioner Representatives have expressed concerns about people who may call to make an order without mentioning the Practitioner Representative who assisted them. When we receive a call, we do our best to learn if a person has spoken with a Practitioner Representative. We want you to do well and want to give credit whenever possible.

If you are asked a question to which you do not know the answer, you can give us a call and then share our response with the person who asked. The more you know as a Practitioner Representative, the more helpful you can be to others.

### **Territories**

Because the spread of information about the Molecular Enhancer has been predominantly from one friend or family member to another, it has not made sense to limit the number of people able to help one another within a community.

I understand that I am demonstrating an **experimental** device that stimulates the body to create its own energy, **not “cure” a health challenge**. The Molecular Enhancer does not cure physical challenges; it helps power the body’s own healing systems.

I understand that Molecular Enhancers sold in America are made in America. DCD Technologies, LLC, is committed to this business practice and costs reflect this practice. **The Molecular Enhancer is not a business centered around profit**. The focus of DCD Technologies, LLC, is on educating people about this technology and keeping the cost to the customer down.

As an MEPR, I acknowledge that I receive a commission only when my ID Number and full name are provided when an order form is submitted with a money order, a check or credit card information, whether it is by mail or by the Internet ordering system. As an MEPR, I will earn a \$250 commission for each Molecular Enhancer sold, starting with the second sale. Commission is for time spent educating and sharing information about the Molecular Enhancer with customers. Average accumulated time spent with a customer is one to two hours. I understand there are no down-line splits being an MEPR. As stated above, sales are viewed as a service with the focus on education and keeping the cost down to the end user.

I am aware that, DCD Technologies, LLC will distribute commission checks to me as the MEPR twice a month, about the 1<sup>st</sup> and the 15<sup>th</sup> of each month.

I know DCD Technologies, LLC, intends for its Representatives to have success in sharing the Molecular Enhancer with others.
